

## **Jacob's Rehabilitation Farm Center Admission Policies – Sponsor**

I, \_\_\_\_\_, agree to sponsor \_\_\_\_\_ as a resident for admission to *Jacob's Rehabilitation Farm Center (JRFC)*. *The resident will sign a separate Admissions Policy agreeing to the policies defined below and I agree to support him in this process. I am also committing to the financial support defined in this policy.*

### ***Resident Policies:***

1. Present psychiatric evaluation, including screenings for TB and HIV prior to admittance.
2. Submit to an interview with the referral agency and members of JRFC staff.
3. If a resident becomes ill, they will be taken to the Corozal Community Hospital for treatment unless they make other arrangements. Any medication needed that the hospital does not provide will need to be bought by the sponsor.
4. When admitted, the resident must bring his own clothing, boots, flashlight, and toiletries.
5. No electronic devices (e.g., cell phones, radio, etc.) are allowed. If detected, any such items will be confiscated and returned at the end of the program.
6. No resident is permitted to have any cash during their time in the program. Any need to purchase outside items will be managed by the immediate supervisor.
7. Obscene language is highly discouraged.
8. Violence or stealing among patients will be dealt with internally or by bringing in the police. Consequences for acts of violence or stealing will result in expulsion from the program. Any unused program fees will not be refunded.
9. Being disrespectful or threatening to the authorities or other residents will be dealt with internally or by bringing in the police if necessary. Depending on the severity of the situation, it could lead to expulsion.

10. Any mind-altering chemicals (unless prescribed by a doctor for medical or psychological reasons) are strictly prohibited, including smoking of any kind. This also applies to other mind-altering behaviors such as gambling, pornography, etc. Anyone caught engaging in any of these will be expelled.
11. Unannounced and random searches of the resident's personal property will be done.
12. Once admitted to JRFC, the resident will commit himself to remain at the center for six months or longer if further treatment is warranted.
13. Residents agree to remain at JRFC except when under supervision or when prior permission has been granted such as home visits. If anyone is caught leaving JRFC without said permission, the following consequences will be enforced:
  - a. First offense, the resident will be placed on one-month probation.
  - b. A second offense will result in the resident being expelled.
14. Residents must participate in all daily activities and farm chores. (Daily activities would include meditation time, classes in Journey to Freedom, Teen Challenge materials, and relapse prevention; attendance at individual counseling sessions, 12-step meetings and any other activity as will otherwise be assigned.) Farm chores consist of assigned tasks that support the maintenance of the farm, e.g., animal husbandry, agricultural planting/harvesting, etc.
15. At the end of a successful six months, the resident will graduate from JRFC with a diploma and a written plan of action for his aftercare.

### ***Resident and Sponsor Policies***

#### **1. Visitation Privileges:**

- a. For the first month of residency, no one is to receive direct phone calls or visits, however we encourage relatives to call the staff to inquire how the resident is doing, leave messages, or send notes of encouragement and any other personal items which will be inspected upon arrival.
- b. After the first month of treatment, relatives may visit on the weekends with prior notice.

- c. With good behavior residents will be allowed home visits at the end of the fifth month. The duration of visits will be at the discretion of JFRC staff.
- d. Transportation must be provided by the sponsor or family member, and they must adhere to the time frame agreed on.
- e. All visits must always be supervised.
- f. All residents will be searched upon re-entry to the farm after visits. If contraband is found the resident is expelled.

2. Calls will be allowed on Sundays ONLY at the resident's own expense. Emergency calls will be allowed at any time. All phone calls will be supervised.

***Sponsor's Financial Obligation***

The Sponsor is required to pay the following fees upon admission to the program:

- Monthly program fee: \$800.00
